

**Midway Rehabilitation Center Prison Rape Elimination Act  
2024 Annual Report**

Midway Rehabilitation Center has a zero-tolerance policy for all acts of sexual abuse and harassment. The Agency has established the Elimination and Reporting of Sexual Abuse and Harassment Policy and Procedures pursuant to the Prison Rape Elimination Act (PREA) Community Corrections Facility Standards, to prohibit and prevent sexual abuse and harassment and to detect, report, investigate, and address any allegation of abuse or harassment involving any adult in the custody of the Bureau of Prisons and residing at Midway Rehabilitation Center.

In 2003, President Bush signed the Prison Rape Elimination Act (PREA) into law. The Department of Justice (DOJ) developed national standards for implementation by federal, state, and local correctional organizations. The intended purpose of these standards was to provide comprehensive guidelines for preventing, detecting, and eliminating incidents of sexual abuse and harassment involving adult inmates and youth in detention and residential facilities. After public review and comment, the DOJ published the final PREA Adult Community Correction standards, which took effect on August 20, 2012, and mandated that all federally operated residential facilities comply with them.

This agency is committed to providing safe and secure environments for young people. Extensive efforts are taken to comprehensively investigate all reported allegations of sexual abuse and harassment. Allegations are reported to the Federal Bureau of Prisons, Knoxville Police Department, and East Tennessee Sexual Assault Center of East Tennessee. Management teams are required to review all investigations to determine the need for corrective actions, which may include policy and procedure modifications, staff and/or adult discipline. Pursuant to PREA Adult Community Confinement Standards §115.287 and §115.288, Midway Rehabilitation Center is mandated to collect data for each allegation of sexual abuse occurring in its facilities. This data must include, at a minimum, the information required to answer all questions in the most recent version of the Department of Justice Bureau of Statistics' Survey of Sexual Victimization. The agency has redacted specific material from publication, such as personal identifying information and information that would present a clear and specific threat to the safety and security of the agency's facilities.

This report presents the DOJ Survey of Sexual Victimization data for the calendar year 2024. The Data is categorized in the following areas.

- Inmate –on-Inmate Nonconsensual Sexual Acts
- Inmate –on-Inmate Abusive Sexual Contact
- Inmate-on-Inmate Sexual Harassment
- Staff Sexual Misconduct
- Staff Sexual Harassment

The DOJ Survey of Sexual Victimization defines four investigation outcomes.

- **Substantiated** - the event was investigated and determined to have occurred, based on a preponderance of the evidence (28 C.F.R. §115.72).
- **Unsubstantiated** - the investigation concluded that evidence was insufficient to determine whether or not the event occurred.
- **Unfounded** - the investigation determined that the event did not occur.
- **Investigation Ongoing** - evidence is still being gathered, processed, or evaluated, and a final determination has not yet been made yet.
- **NONPREA** – Not a PREA incident
